General

- Gently rinse the affected eye(s) with clean, cool water for at least 15 minutes. Have the patient lie or sit down and tilt the head back. Hold the eyelid(s) open and pour water slowly over the eyeball(s) at the inner corners, letting the water run out of the outer corners.
- ► The patient may be in great pain and wish to keep the eyes closed. It is important that the material is rinsed from the eyes to prevent further damage.
- Ensure that the patient looks up, and side to side as the eye is rinsed in order to better reach all parts of the eye(s)
- Transport to hospital or doctor.
- Even when no pain persists and vision is good, a doctor should examine the eye as delayed damage may occur.

## 4.3. Indication of any immediate medical attention and special treatment needed

For acute or short term repeated exposures to petroleum distillates or related hydrocarbons:

- Primary threat to life, from pure petroleum distillate ingestion and/or inhalation, is respiratory failure.
- Patients should be quickly evaluated for signs of respiratory distress (e.g. cyanosis, tachypnoea, intercostal retraction, obtundation) and given oxygen. Patients with inadequate tidal volumes or poor arterial blood gases (pO2 50 mm Hg) should be intubated.
- Arrhythmias complicate some hydrocarbon ingestion and/or inhalation and electrocardiographic evidence of myocardial injury has been reported; intravenous lines and cardiac monitors should be established in obviously symptomatic patients. The lungs excrete inhaled solvents, so that hyperventilation improves clearance.
- A chest x-ray should be taken immediately after stabilisation of breathing and circulation to document aspiration and detect the presence of pneumothorax.
- Epinephrine (adrenalin) is not recommended for treatment of bronchospasm because of potential myocardial sensitisation to catecholamines. Inhaled cardioselective bronchodilators (e.g. Alupent, Salbutamol) are the preferred agents, with aminophylline a second choice.
- Lavage is indicated in patients who require decontamination; ensure use of cuffed endotracheal tube in adult patients. [Ellenhorn and Barceloux: Medical Toxicology]
  For frost-bite caused by liquefied petroleum gas:
- If part has not thawed, place in warm water bath (41-46 C) for 15-20 minutes, until the skin turns pink or red.
- Analgesia may be necessary while thawing.
- If there has been a massive exposure, the general body temperature must be depressed, and the patient must be immediately rewarmed by whole-body immersion, in a bath at the above temperature.
- Shock may occur during rewarming.
- Administer tetanus toxoid booster after hospitalization.
- Prophylactic antibiotics may be useful.
- The patient may require anticoagulants and oxygen.

- Establish a patent airway with suction where necessary.
- Watch for signs of respiratory insufficiency and assist ventilation as necessary.
- Administer oxygen by non-rebreather mask at 10 to 15 l/min.
- Monitor and treat, where necessary, for pulmonary oedema .
- Monitor and treat, where necessary, for shock.
- Anticipate seizures.

## ADVANCED TREATMENT

- Consider orotracheal or nasotracheal intubation for airway control in unconscious patient or where respiratory arrest has occurred.
- Positive-pressure ventilation using a bag-valve mask might be of use.
- Monitor and treat, where necessary, for arrhythmias.

- Start an IV DSW TKO. If signs of hypovolaemia are present use lactated Ringers solution. Fluid overload might create complications.
- Drug therapy should be considered for pulmonary oedema.
- Hypotension with signs of hypovolaemia requires the cautious administration of fluids. Fluid overload might create complications.
- Treat seizures with diazepam.
- Proparacaine hydrochloride should be used to assist eye irrigation.

#### SECTION 5 FIREFIGHTING MEASURES

## 5.1. Extinguishing media

DO NOT EXTINGUISH BURNING GAS UNLESS LEAK CAN BE STOPPED SAFELY:

OTHERWISE: LEAVE GAS TO BURN.

#### FOR SMALL FIRE:

- Dry chemical, CO2 or water spray to extinguish gas (only if absolutely necessary and safe to do so).
- DO NOT use water jets.

#### FOR LARGE FIRE:

• Cool cylinder by direct flooding quantities of water onto upper surface until well after fire is out.

### 5.2. Special hazards arising from the substrate or mixture

Fire Incompatibility

Avoid contamination with oxidising agents i.e. nitrates, oxidising acids, chlorine bleaches, pool chlorine etc. as ignition may result

## 5.3. Advice for firefighters

FOR FIRES INVOLVING MANY GAS CYLINDERS:

- To stop the flow of gas, specifically trained personnel may inert the atmosphere to reduce oxygen levels thus allowing the capping of leaking container(s).
- Reduce the rate of flow and inject an inert gas, if possible, before completely stopping the flow to prevent flashback.
- ▶ DO NOT extinguish the fire until the supply is shut off otherwise an explosive re-ignition may occur.
- > If the fire is extinguished and the flow of gas continues, used increased ventilation to prevent build-up, of explosive atmosphere.

#### Fire Fighting

## GENERAL

- Alert Fire Brigade and tell them location and nature of hazard.
- May be violently or explosively reactive.
- Wear breathing apparatus plus protective gloves.
- Consider evacuation
- Fight fire from a safe distance, with adequate cover.
- ► HIGHLY FLAMMABLE: will be easily ignited by heat, sparks or flames.
- ▶ Will form explosive mixtures with air
- Fire exposed containers may vent contents through pressure relief valves thereby increasing fire intensity and/or vapour concentration.
- Vapours may travel to source of ignition and flash back.
- Fire/Explosion Hazard
- ► Containers may explode when heated Ruptured cylinders may rocket
- Fire may produce irritating, poisonous or corrosive gases.

Combustion products include; carbon monoxide (CO) carbon dioxide (CO2) other pyrolysis products typical of burning organic material Contains low boiling substance: Closed containers may rupture due to pressure buildup under fire conditions.

Vented gas is more dense than air and may collect in pits, basements.

## 6.3. Methods and material for containment and cleaning up

Minor Spills

- Avoid breathing vapour and any contact with liquid or gas. Protective equipment including respirator should be used.
- DO NOT enter confined spaces where gas may have accumulated.
- ▶ Shut off all sources of possible ignition and increase ventilation.
- Clear area of all unprotected personnel and move upwind.
- Alert Emergency Authority and advise them of the location and nature of hazard.
- May be violently or explosively reactive.

Major Spills

- Wear full body clothing with breathing apparatus.
- Remove leaking cylinders to a safe place.
- Fit vent pipes. Release pressure under safe, controlled conditions
- Burn issuing gas at vent pipes.
- ▶ DO NOT exert excessive pressure on valve; DO NOT attempt to operate damaged valve.

## 7.1. Precautions for safe handling

- Containers, even those that have been emptied, may contain explosive vapours.
- Do NOT cut, drill, grind, weld or perform similar operations on or near containers.
- Electrostatic discharge may be generated during pumping this may result in fire.
- Ensure electrical continuity by bonding and grounding (earthing) all equipment.
- Restrict line velocity during pumping in order to avoid generation of electrostatic discharge (<=1 m/sec until fill pipe submerged to twice its diameter, then <= 7 m/sec).</li>
- Safe handling Avoid splash filling.
  - Consider use in closed pressurised systems, fitted with temperature, pressure and safety relief valves which are vented for safe dispersal.
  - The tubing network design connecting gas cylinders to the delivery system should include appropriate pressure indicators and vacuum or suction lines.
  - Fully-welded types of pressure gauges, where the bourdon tube sensing element is welded to the gauge body, are recommended.
  - ▶ Before connecting gas cylinders, ensure manifold is mechanically secure and does not containing another gas.
  - Avoid generation of static electricity. Earth all lines and equipment.
  - DO NOT transfer gas from one cylinder to another.

## 8.2. Exposure controls

8.2.1. Appropriate engineering controls Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.

The basic types of engineering controls are:

Process controls which involve changing the way a job activity or process is done to reduce the risk.

Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment.

- Full face shield may be required for supplementary but never for primary protection of eyes.
- Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the

Insulated gloves:

When handling sealed and suitably insulated cylinders wear cloth or leather gloves.

NOTE: Insulated gloves should be loose fitting so that may be removed quickly if liquid is spilled upon them. Insulated gloves are not made to permit hands to be placed in the liquid; they provide only short-term protection from accidental contact with the liquid.

**Body protection**

- ► The clothing worn by process operators insulated from earth may develop static charges far higher (up to 100 times) than the minimum ignition energies for various flammable gas-air mixtures. This holds true for a wide range of clothing materials including cotton.
- ▶ Avoid dangerous levels of charge by ensuring a low resistivity of the surface material worn outermost.

- Protective overalls, closely fitted at neck and wrist.
- ► Eye-wash unit.

## Other protection

- IN CONFINED SPACES:
  - Non-sparking protective boots
- Static-free clothing.
- ► Ensure availability of lifeline.

Some plastic personal protective equipment (PPE) (e.g. gloves, aprons, overshoes) are not recommended as they may produce static electricity. For large scale or continuous use wear tight-weave non-static clothing (no metallic fasteners, cuffs or pockets).

Non sparking safety or conductive footwear should be considered. Conductive footwear describes a boot or shoe with a sole made from a conductive compound chemically bound to the bottom components, for permanent control to electrically ground the foot an shall dissipate static electricity from the body to reduce the possibility of ignition of volatile compounds.

### SECTION 11 TOXICOLOGICAL INFORMATION

## 11.1. Information on toxicological effects

Inhalation of vapours may cause drowsiness and dizziness. This may be accompanied by sleepiness, reduced alertness, loss of reflexes, lack of co-ordination, and vertigo.

Inhalation of vapours or aerosols (mists, fumes), generated by the material during the course of normal handling, may be damaging to the health of the individual.

There is some evidence to suggest that the material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage

Isobutane produces a dose dependent action and at high concentrations may cause numbness, suffocation, exhilaration, dizziness, headache, nausea, confusion, incoordination and unconsciousness in severe cases.

The paraffin gases are practically not harmful at low doses. Higher doses may produce reversible brain and nerve depression and irritation. Inhalation of high concentrations of gas/vapour causes lung irritation with coughing and nausea, central nervous depression with headache and dizziness, slowing of reflexes, fatigue and inco-ordination.

Inhaled

Central nervous system (CNS) depression may include general discomfort, symptoms of giddiness, headache, dizziness, nausea, anaesthetic effects, slowed reaction time, slurred speech and may progress to unconsciousness. Serious poisonings may result in respiratory depression and may be fatal.

Nerve damage can be caused by some non-ring hydrocarbons. Symptoms are temporary, and include weakness, tremors, increased saliva, some convulsions, excessive tears with discolouration and inco-ordination lasting up to 24 hours.

Material is highly volatile and may quickly form a concentrated atmosphere in confined or unventilated areas. The vapour may displace and replace air in breathing zone, acting as a simple asphyxiant. This may happen with little warning of overexposure.

Symptoms of asphyxia (suffocation) may include headache, dizziness, shortness of breath, muscular weakness, drowsiness and ringing in the ears. If the asphyxia is allowed to progress, there may be nausea and vomiting, further physical weakness and unconsciousness and, finally, convulsions, coma and death.

Exposure to hydrocarbons may result in irregularity of heart beat. Symptoms of moderate poisoning may include dizziness, headache, nausea.

Ingestion

Considered an unlikely route of entry in commercial/industrial environments | Not normally a risk due to extreme volatility of liquid.

The material is not thought to produce adverse health effects or skin irritation following contact (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable gloves be used in an occupational setting.

Repeated exposure may cause skin cracking, flaking or drying following normal handling and use.

Open cuts, abraded or irritated skin should not be exposed to this material

Skin Contact

Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.

Vapourising liquid causes rapid cooling and contact may cause cold burns, frostbite, even through normal gloves. Frozen skin tissues are painless and appear waxy and yellow. Signs and symptoms of frost-bite may include "pins and needles", paleness followed by numbness, a hardening an stiffening of the skin, a progression of colour changes in the affected area, (first white, then mottled and blue and eventually black; on recovery, red, hot, painful and blistered).

Although the material is not thought to be an irritant (as classified by EC Directives), direct contact with the eye may produce transient discomfort characterised by tearing or conjunctival redness (as with windburn).

Not considered to be a risk because of the extreme volatility of the gas.

Chronic

Substance accumulation, in the human body, may occur and may cause some concern following repeated or long-term occupational exposure. Principal route of occupational exposure to the gas is by inhalation.

Constant or exposure over long periods to mixed hydrocarbons may produce stupor with dizziness, weakness and visual disturbance, weight loss and anaemia, and reduced liver and kidney function. Skin exposure may result in drying and cracking and redness of the skin.
